*Membership of the Society shall be open to anyone who has an interest in Cartography*

**ORDINARY MEMBERS** - persons over 21 years of age, who satisfy the Council of their interest in Cartography.

**ASSOCIATE MEMBERS** - persons under 21 years of age, the unwaged, registered students or those in receipt of a state retirement pension who satisfy Council of their interest in Cartography.

**CORPORATE MEMBERS** - organisations interested directly in Cartography such as Government Departments, Universities, Manufacturers of Cartographic Equipment or Map Publishing Companies.

**SMALL CORPORATE MEMBERS** — small cartographic businesses with less than 10 employees or with an annual turnover of less than £250,000.

**FELLOWS** - Existing Ordinary Members meeting the criteria for professional competence upon whom the Council may see fit to confer Fellowship status. Details may be obtained from the Fellowship Office at BCS Administration.
