Membership categories

Full member £40.00 per annum (£55.00 overseas)
Persons over 18 years of age who normally are, or have been, professionally engaged in mapping or associated fields, or who have a substantial interest in maps or cartography.

Affiliate member £20.00 per annum (£35.00 overseas)
Persons of any age and who have an interest in maps and cartography.

Student member £20.00 per annum (£35.00 overseas)
Persons of any age that are engaged in full-time education and who have an interest in maps and cartography (proof of status required).

Corporate member £200.00 per annum (£215.00 overseas)
Organisations interested directly in cartography, such as government departments, manufacturers of cartographic equipment, or map publishing companies.

Small corporate member £100.00 per annum (£115.00 overseas)
Cartographic businesses with fewer than 20 employees or with an annual turnover of less than £500,000 (or equivalent).

Educational member £60.00 per annum (£75.00 overseas)
Educational establishments, such as schools, colleges and universities.

Fellow - FBCart.S £60.00 per annum (£75.00 overseas)

Special interest groups

Map Curators' Group (MCG) caters for librarians, map historians, collectors and archivists. A newsletter, *Cartographiti*, is issued up to three times a year; a workshop and specialist visit is arranged annually.
